

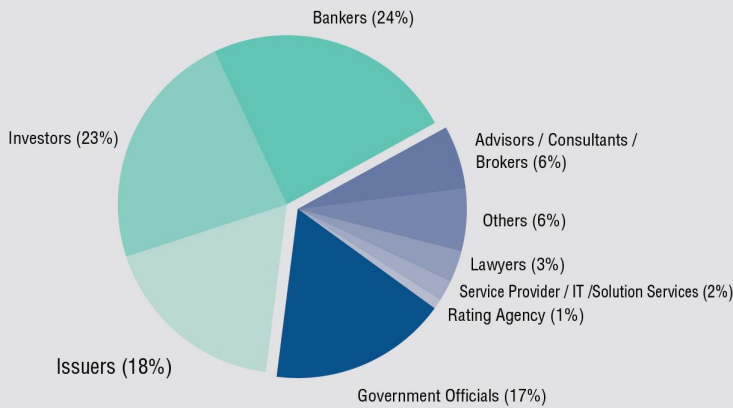
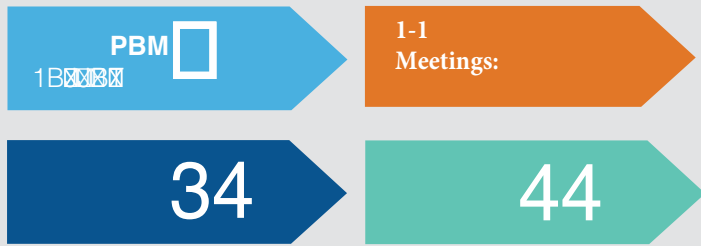


NOVEMBER 17, 2016 | MONTEGO BAY CONVENTION CENTRE | JAMAICA

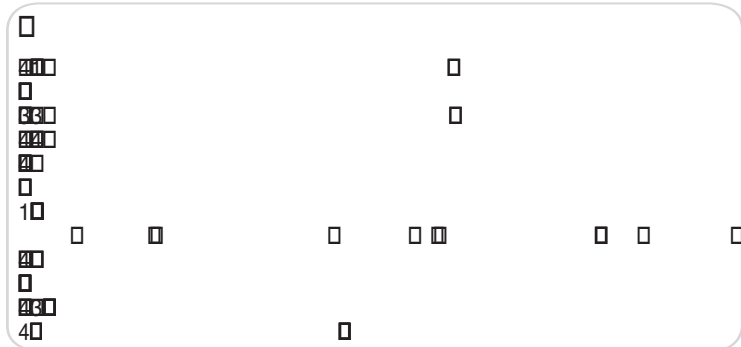
